The Government indicates that difficulties relating to the collection of up-to-date statistics on child victims of trafficking include a lack of regular exchanges of information with civil society organizations in Burundi. The government did not encourage victims to assist in the investigation or prosecution of trafficking cases. The lack of coordination and data collection on anti-trafficking efforts in Burundi remains a serious concern.

This body can be outside the NAP and does not have to focus solely on modern slavery. If policy is in place, there MUST be evidence that this has occurred since 30 June OR if the policy has just been adopted, it is enough that reporting is stipulated as part of regulating compliance. Forced or compulsory labour means all work or service which is exacted from any person under the menace of any penalty and for which the said person has not offered himself or herself voluntarily.
